

# Polish Tatra Sheepdog Club of America Registration of Foreign - Imported Dog

## PLEASE READ INSTRUCTIONS BEFORE COMPLETING

1. Application must be completely filled out, either legibly printed in ink or typed, and signed in ink.
2. A very clear photocopy of the original Certificate of Registration and 3 generation pedigree, which indicates the dog's registry and owner of record, must be included.
3. The \$15.00 fee must be included with the application form. It must be a check or money order payable in US funds, made out to the PTSCA.
4. All foreign dogs being registered with PTSCA must have positive identification. See application form.
5. The dog being registered with PTSCA must be registered with the name that appears on the foreign registration certificate and 3 generation pedigree.
6. The person listed on the export/foreign registration! 3 generation pedigree as owner, must be the same person who is applying for registration with the PTSCA.
7. The person applying for foreign dog registration with PTSCA must already be a member in good standing with the PTSCA.
8. Four (4) clear color photographs of the dog in a standing position, close up; right side, left side, front and back, which shows the whole dog must be included with this application and will not be returned.
9. The PTSCA reserves the right to correct or revoke with just cause the registration of this dog. Any misrepresentation on this application is cause for cancellation and may result in loss of all PTSCA privileges.
